

PERSONAL RESPONSIBILITY COMMITMENT

All foreigners and citizens of the Republic of Lithuania residing abroad, who have arrived in the Republic of Lithuania for study purposes from countries outside the European Economic Area, Switzerland, and the United Kingdom, also from the countries that are included in the list of the countries affected by COVID-19¹ are required to **isolate for 14 calendar days**. The Decision is taken by the Ministry of Health of the Republic of Lithuania and approved by the Parliament of the Republic of Lithuania.

On your arrival, you are required to **register at the National Public Health Centre** under the Ministry of Health within **24 hours** by completing the form, which is available online <https://keleiviams.nvsc.lt/en/form>

All foreigners arriving from the outside the European Economic Area, Switzerland, and the United Kingdom, also from the countries that are included in the list of the countries affected by COVID-19 are required to have a negative COVID-19 test valid for 72 hours. Otherwise you have to contact hotline +370 618 79984 and +370 616 94562 or 1808 (short number from local phone) within **24 hours** in order to be **tested for the coronavirus**.
